Accordingly, the JKSSB invites online application forms from eligible candidates for participating in the selection process for the aforementioned posts. The important dates/details with regard to the posts being advertised are as under:

- a) Date of Commencement for submission of Online Application Forms: 30.07.2024.
- b) Cut-off Date i.e. Last Date for submission of Online Application Forms: 29.08.2024.

The detailed Terms and Conditions with regard to eligibility, educational qualification, domicile, reservation, physical standards etc. for participating in the selection process for the aforementioned posts are as under:

#### 01) APPOINTMENT OF THE CANDIDATES:

The Appointment and other service conditions in respect of the candidates selected through this selection process, shall be governed as per extant rules/regulations.

# 02) DOMICILE:

The candidates seeking to apply for the advertised posts shall be Domiciles of the Union Territory of Jammu & Kashmir and must possess a <u>valid Domicile Certificate issued by the</u> <u>Competent Authority on the prescribed format on or before the cut-off date i.e. last</u> <u>date of submission of online application forms</u>, which, unless otherwise extended, shall be **29.08.2024**.

#### 03) VACANCIES:

The details of posts advertised are given in **Annexure-A** to this Notification. <u>However</u>, the number of posts can undergo increase or decrease without any Notice before the completion of the selection process, if so communicated by the concerned Indenting Department.

## 04) AGE LIMIT:

The **requirement of age** for applying against these posts, as on **01.01.2024** for Open Merit & various Reserved Categories Candidates, shall be as under:

#### 05) OUALIFICATION REQUIRED:

- a) As per the Indent received from the Indenting Department and relevant recruitment rules, the qualification prescribed for the advertised posts is shown in Annexure-A to this Notification.
- b) The candidates who are declared qualified by the Board for Document Verification will be required to produce relevant Certificates in original as proof of having acquired the prescribed educational qualification on or before the cut-off date fixed for filling online application forms, failing which the candidature of such candidates shall be cancelled by the Board.
- c) Candidates may note that their candidature/admission in examination will remain provisional till the genuineness of their documents relating to educational qualification is verified by the Appointing Authority.
- d) In case of candidates claiming possession of equivalent educational qualification (where it is applicable/required), it shall be mandatory to produce relevant Equivalence

Certificate or seek equivalence from the concerned competent authorities as and when required by the Board. *However, final decision regarding selection of such candidates will be taken by the Board, in light of relevant rules which shall be binding.* 

e) Any candidate having his/her qualification other than as prescribed, shall not be eligible for posts advertised in this notification and such candidature will be summarily rejected.

#### 06) <u>APPLICATION OF RESERVATION:</u>

- a) The Reservation for the posts under this Advertisement Notification shall be applicable as per the category-wise break up of vacancies as conveyed by the Indenting Department and in accordance with the provisions of the Jammu & Kashmir Reservation Act/Rules, as amended from time to time.
- b) A candidate seeking his /her consideration under Reserved Categories must ensure that he/she possess a valid/ Category Certificate as on the Cut Off Date.
- c) Candidates may note that their candidature will remain provisional till the genuineness of the Reserved Category Certificate is verified by the Appointing Authority.
- d) Candidates are cautioned to note that in case a claim for reservation is made on the basis of false/fake/fraudulent certificate, he/she shall be debarred from the examination(s) conducted by the Board, in addition to any other action as may be deemed appropriate.

#### 07) HORIZONTAL RESERVATION (wherever applicable under rules):

- a) Horizontal Reservation means the reservation which would cut across the vertical reservation and the persons selected shall have to be placed in the appropriate category by making necessary adjustments.
- b) Persons with Disability (PwD) are not eligible for these posts and as such, Horizontal Reservation is not applicable to the PwD candidates for these posts.
- c) Horizontal Reservation to the extent of 6% shall be applicable to the Ex-Servicemen (ESM).
- d) In terms of S.O. 361 of 2021 dated 20.10.2021, an Ex-Serviceman on joining any post after having availed Horizontal Reservation, cannot avail of the benefit of Horizontal Reservation as Ex-Servicemen for any subsequent Employment. A candidate seeking to apply under ESM category shall be required to submit an affidavit in this regard at the time of scrutiny of documents.
- e) ESM candidates shall be required to produce a Certificate in form-XIV duly signed by the competent authority as provided in the Rule 18 of Jammu and Kashmir Reservation Rules, 2005.
- f) In case sufficient number of candidates belonging to the Ex-servicemen are not available on the basis of General standard to fill all the vacancies reserved for them, candidates belonging to the category of Ex-servicemen may be selected under the relaxed standard of selection to make up the deficiency in the reserved quota subject to the condition that such relaxation will not affect the level of performance by such candidates.
- g) In terms of S.O. 288 dated 14.06.2022, of Home Department, Horizontal Reservation to the extent of 15% of the available vacancies in direct recruitment shall be earmarked for women candidates in non-gazetted ranks. The quota so reserved shall not be carried forward to the subsequent year, in case suitable women candidates are not available.
- h) In terms of S.O. 339 dated 19.06.2024, Horizontal Reservation to the extent of 15% of the available vacancies for SPOs and 4% of available vacancies for Volunteer Home Guards(VHGs) at the level of Constable in direct recruitment shall be earmarked in favour of the said categories having minimum three years of engagement. The quota so reserved shall not be carried forward to the subsequent year, in case eligible candidates are not available. The authority to certify 3 year engagement of SPO/VHG shall be concerned Zonal/Wing heads.

## 08) APPLICATION FEE:

- a) Fee payable: Rs.700/-(Rupees Seven Hundred only). In case of candidates belonging to SC, ST-1,ST-2 and EWS category, the fee payable shall be Rs.600/-(Rupees Six Hundred only).
- b) Fee can be paid only through online mode viz. Net Banking, Credit or Debit cards.
- c) Applications received without the prescribed fee shall not be considered and shall be summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection.
- d) All the disputes related to refund of excess payment, if any, are subject matter of the J&K Service Selection Board. Candidates are advised to apply for refund of excess payment, if any, through official e-mail ssbjkgrievance@gmail.com only. No chargeback request shall be entertained.

# 09) DATE & CENTRE OF EXAMINATION:

The J&K Services Selection Board shall notify the dates for examination and the Venue/Centre(s) of examination separately. The details shall be made available on the website of the Board **www.jkssb.nic.in**. No representation/request for change in this regard shall be entertained, whatsoever be the reason.

#### 10) SCHEME OF EXAMINATION:

#### (I) WRITTEN EXAMINATION:

- a) The Examination will consist of Objective Type Multiple Choice Questions. The questions will be set in English Language only.
- **b)** There will be Negative Marking for each wrong answer to the extent of one-fourth of marks assigned to that question.
- c) In terms of SO 290 dated 20.08.2021 of Home Department, the candidates possessing National Cadet Corps (NCC) Certificate shall be awarded bonus marks, at the following scales:
  - i) 5% of the maximum marks of the examination for NCC "C" Certificate holders.
  - ii) 3% of the maximum marks of the examination for NCC "B" Certificate holders.
  - iii) 2% of the maximum marks of the examination for NCC "A" Certificate holders.
- (II) <u>PHYSICAL STANDARD TEST</u>: The candidates shall be shortlisted for appearing in the physical standard test on the basis of written test which shall be six times the total number of vacancies to be filled up in each category. The shortlisted candidates should meet the following physical standards:

#### a) For Males:

- i) Height: 5'-6" (minimum)
- ii) Chest girth: 32" (unexpanded)
- iii) Chest girth: 33 1/2" (expanded)

b) For Females: Height: 5'-2" (minimum)

#### **Relaxation in Physical Standard:**

For the candidates belonging to the Gorkha Community and Bot Tribe, the minimum Height shall be relaxable by 2".

(III) **PHYSICAL ENDURANCE TEST:** The candidates who meet the above physical standards shall be required to undergo physical endurance test, which shall consist of the following:

#### A) I) For Male candidates

#### II) For Female candidates

# B) <u>Special provisions regarding relaxation in Physical Endurance Test for</u> <u>Ex-Serviceman:</u>

The Ex- Serviceman candidates shall be required to qualify Physical Endurance Test as per the following relaxed standards:

**Explanation I**: For the purpose of this rule, the age of the Ex-Serviceman shall be his actual age i.e.as on 1<sup>st</sup> January of 2024.

**Explanation II:** All Ex-Servicemen shall be required to pass the written tests and fulfill the prescribed physical standards apart from meeting the medical standards prescribed for direct recruits.

**Note:** The Physical Standard Test and Physical Endurance Test shall be of qualifying nature only.

#### C) Medical Examination

The selected candidates, with reference to the vacancies, will be medically examined to assess their physical and medical fitness.

#### 11) SYLLABI FOR THE POSTS:

The Syllabus for the posts shall be notified separately and made available on the official website of JKSSB.

#### 12) ADMISSION TO THE EXAMINATION:

a) The Board will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of written examination and, therefore, candidature will be accepted only provisionally. The candidates are advised to go through the requirements of educational qualification, age, and reserved category and satisfy themselves that they are eligible for the post. Copies of supporting documents will be sought at the time of Document Verification. When scrutiny is undertaken, if any claim made in the application is not found substantiated or correct, the candidature will be cancelled, and Criminal Proceedings under law may also be initiated, or any other action as may be deemed appropriate by the Board, shall be taken.

- b) All candidates who register themselves in response to this Advertisement Notification, by the closing date and time and whose applications are found to be in order, and are provisionally accepted by the Board as per the terms and conditions of this Advertisement Notice, will be assigned Roll numbers and issued Admit Card/Roll No. slips for appearing in the Written Examination.
- c) The Examination details will be uploaded on the official website of the Board i.e. www.jkssb.nic.in. Examination detail/Roll Number slips will not be issued by post for any stage of examination. Therefore, candidates are advised to visit the official website of Board regularly for updates and information about the examination.
- d) Candidate must submit his/her online Application form, Email-ID and Mobile Number along-with his/her Name, Date of Birth and Name of the Examination, while addressing any communication to the Board. Communication from the candidate not furnishing these particulars shall not be entertained.
- e) Facility for downloading of Admit Cards, as may be notified will be available about one week before the Date of Examination on the official website of the Board. Candidate must bring printout of the Admit Card/Roll Number Card/Slip to the Examination Hall.
- f) In addition to the Roll Number Card/Slip, it is mandatory to carry at least two passport size recent (not older than 06 months, with date mentioned) colour photographs, Original valid Photo-ID proof such as:

  - Voter's ID Card,
  - > Driving License,

# 13) DOCUMENT VERIFICATION (DV):

- a) The candidates who are shortlisted for Document Verification will be required to appear for Document Verification along-with the original documents as well as selfattested Photostat copy of each document/certificate/Online application form as per the Advertisement Notification.
- b) The candidate must be in possession of the prescribed academic qualification and other documents like Birth Certificate, Domicile Certificate, Category Certificate, etc. on or before the last date of submission of online application form.
- c) The candidate must appear with original Domicile Certificate/Qualification/ Category/Bonafide Certificate/s etc. before the Document Verification Committee as may be constituted for such purpose by the Board. In case a candidate fails to appear before the DVC or fails to produce relevant documents/testimonials in original on the scheduled date of DV, he/she shall not be considered for selection.
- d) No TA/DA will be paid for participation in the written test/ document verification.
- e) Candidates shall be required to bring two passport size recent colour photographs and to produce a valid ID Proof in original at the time of Document Verification.
- f) Wherever a specific format has been prescribed for any certificate, in accordance with the relevant rules/orders, a candidate shall be supposed to furnish the said requisite documents in the prescribed format at the time of Documents Verification, otherwise his/her candidature shall be liable for cancellation/rejection.
- g) Candidates who wish to be considered against reserved vacancies or availing such age relaxation wherever applicable, must submit requisite certificate/documents from the Competent Authority in the prescribed format when such certificates are sought by the Board at the time of Document Verification, otherwise their claim will not be entertained & their candidature shall be considered under Open Merit Category.
- h) Candidates claiming to be the Domicile of Jammu & Kashmir shall be asked to produce the Domicile Certificate in original issued by the competent authority up to the cutoff date, in the prescribed format at the time of Document Verification or as and when sought by the Board.

- i) Ex-Serviceman candidates shall be required to produce a Certificate in form XIV duly signed by the competent authority as provided in Rule 18 of Jammu and Kashmir Reservation Rules, 2005.
- j) Bonafide Certificate on the format prescribed by the Board duly issued by the Controller/Registrar of the concerned University in respect of the candidates, who have obtained Degree from the Universities/Colleges/Institutes outside the UT of J&K and other than Central Universities.
- **k)** In addition, any other Certificate, as may be required as part of the eligibility for a specific post, shall also be produced at the time of the DV.

# 14) MISCONDUCT/MALPRACTICE:

If any candidate is found indulging in any irregularity/misconduct/malpractice at any stage of selection process, such candidate shall be debarred from the examinations conducted by the Services Selection Board for such period as may be deemed appropriate, and apart from cancellation of candidature for the instant examination any other action as would be necessary & expedient, shall be taken.

#### 15) STEPS TAKEN FOR FAIRNESS & TRANSPARENCY IN EXAMINATION PROCESS:

The Board, for the purposes of ensuring integrity, fairness and transparency in the Examination process shall be well within its rights & duties, to take steps as necessary or issue instructions as deemed appropriate, at any stage of selection process, and all such steps/instructions shall be deemed to have been taken/given in furtherance of its mandate, as enshrined in the relevant laws/rules/regulations.

# 16) BOARD'S DECISION FINAL:

The decision of the Board in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s), allotment of examination centers and preparation of merit list & Cadre/Department allocation, debarment for indulging in malpractices would be final and binding on the candidates and no enquiry/ correspondence will be entertained in this regard.
